Old Business:

North/South of Goodrich Walkway Improvement- JoAnne- Dircio Landscaping is just finishing up and it looks great!

Bylaws Amendment/'Opt In' Letter: JoAnne has sent letters to the 5 households that have asked to voluntarily opt into the Association. Chris Ries advised that the opt-in document needed to include a Notary, none of which have been returned.

Storage Shed & Bathroom for Upper Park – Elton has sent a memo of understanding to PP Water Company acknowledging their ownership of the pump-house and property. We will continue to maintain and water the grass on the property. Any damage to the irrigation system will be their responsibility to fix.
